Peter Cauble and Allies Research

1786 — **Peter Cauble** was born to unidentified parents in NC. [Headstone of Peter Cauble, Cauble-Burch Cemetery, Peachtree Village, Tyler Co.TX; 1850 U. S. Census, Tyler Co.TX; Family tradition has variously reported his father's name as Adam, Andrew, and Henry.]

1794 — **Mary Rotan** was born in SC to **William Rotan and his wife**, perhaps named **Rosey**. [Headstone of Mary Rotan Cauble, Cauble-Burch Cemetery, Peachtree Village, Tyler Co. TX; 1850 U. S. Census Tyler Co. TX; Barren Co. KY Deed Book A, p. 450.]

01 Jun 1796 — **Tennessee** became the sixteenth state of the Union.

Summer 1800 — **William Rotan** left Barren Co. KY for Jackson Co. TN. [Michael A. Ports, "In Search of William Rotan," *The Texas Caubles* 4:2 (30 Dec 1993), 1-7.]

1802 — **Peter Cauble** was of taxable age [16 and above in most frontier counties]. However, Harriette Simpson Arnow, in describing life in the Cumberland around the turn into the nineteenth century, states: "Not all men who had to pay only poll tax took the trouble to enter their names on the tax rolls." [Harriette Simpson Arnow, *Flowering of the Cumberland* (Lexington: The Univ. of KY Press, 1984), 88.]

1802 — **William Rotten** paid one white poll and 3 slave polls in Captain Lowrey's District, Jackson Co. TN. **Garrot Fitzgerald** paid taxes on 1,111 acres of land and no poll [*probable reason*: over age 55] in Captain **Jabez Fitzgerald's** District, Jackson Co. TN. [1802 Tax List, Jackson Co. TN.]

09 Mar 1802 — **Rich Ratton** [son of **Wm.**?] received 200 acres in Jackson Co. [parent of White Co.] TN on the south branch of Spring Creek, including his own improvement. [Middle TN Entry Book 54, p. 4, No. 8.]

1803 — **William Rotton** paid one white poll and 3 slave polls in Captain Parson's District, Jackson Co. TN. **Richard Rotton** paid one poll in Captain Parson's District (no land?). **Garret Fitzgerald** paid no white polls, 4 slaves polls, and was taxed for 1,000 acres of land in Captain Fitzgerald's District. Also in Fitzgerald's District, **Jabez Fitzgerald** paid one white poll. [1803 Tax List, Jackson Co. TN.]

Peter Cauble and Allies Research

1806 — White Co. TN was formed from Overton, Jackson, and Smith counties TN, with Sparta as seat. [*Handy Book for Genealogists* (Logan UT: The Everton Publishers, Inc., 1981), 273.]

11 Aug 1807 — **William Rotton**, assignee of Julius Sumner's heirs, warrant no. 4701, received a grant of 320 acres in 3rd District of White County TN on Lost Creek waters of Caney Fork. [White County TN Deed Book C, p. 232.] "**Lost Creek**, an east branch of Tennessee [River], in Stewart county." [*Tennessee Gazetteer 1834*, 118.]

c1808-1810 — **Mary Ann Rotan**, daughter of **William Rotan**, married **Peter Cauble** in White Co. TN. [Body of evidence: Wm. Rotan's will; reconstructed birth dates of Cauble children.]

c1808-1810 — **Elizabeth Cauble** [who later married ___ **Osborn/Osborne**] was born to Mary Ann Rotan and Peter Cauble in White Co. TN. [1830 U. S. Census Marion Co. AL; Peter Cauble Will, Tyler Co. TX Probate Record, Vol. D, pp. 885-887; Cauble named his children in birth order as researchers know them and it is assumed that *he followed that pattern consistently even with the births researchers cannot definitely date.*—jcs]

21 Apr 1810 — **William Rotton** received from Tennessee the Julius Sumner Land Grant No. 2182 for his [Sumner's] military service to the state of North Carolina, Warrant 4701, dated 14 Feb 1797, for 320 acres in 3rd District on Lost Creek waters of Caney Fork; surveyed 17 Aug 1808 by Isaac Taylor, Junr, DS. [White Co. TN Deed Records, Vol. C, p. 232.]

29 Oct 1810 — **Richard M. Rotton** was commissioned captain in the 34th regiment from White Co. TN. [*Record of Commissions of Officers in the Tennessee Militia, 1796-1815*, compiled by Mrs. John Trotwood Moore (Baltimore: Genealogical Co., Inc., 1977), 103-104.]

1811 — **Richard M. Rotton** paid 1 white poll and taxes on 100 acres by grant in Hickory Valley in White Co. TN on the tax list of Captain Richard M. Rotton's Company of Militia. **William Rotton** paid 1 white poll, 3 black polls, and taxes on 320 acres by grant on Lost Creek in White Co. TN [1811 Tax List of Captain Richard M. Rotton's Company of Militia, White Co. TN.]

31 Oct 1811 — **Wm. Rowton, wife and 4 children** from Barnwell Dist. SC were given passports through the Creek Nation to Western Country. [*Passports of Southeastern Pioneers 1770-1823*, compiled by Dorothy Williams Potter (Baltimore: Gateway Press, Inc., 1982), 290. These passports are listed in the Georgia section, meaning the travelers were leaving Georgia to cross "the Indian Nations to the Western Country." Western country referred to "Louisiana, Mississippi, and Alabama." [*Passports of Southeastern Pioneers 1770-1823*, p. 170]

Peter Cauble and Allies Research

Note: The following is the first public record for Peter Cauble found thus far by Cauble researchers. Since he was living in the same county with the Rotans, it appears that this is the right man. The birth of Elizabeth Cauble who married James? Osborne has been set as c1810. If that date is close to true, Peter and Mary Ann married c1808-1809 [when she was 15 and he was 23]. The marriage was surely in White Co.TN simply because Mary Ann's family lived there. Females lived at home until marriage.

Cauble researchers do not know when their Peter Cauble met the Rotan family. The two families may have been neighbors for decades and migrated together; it is doubtful that Peter migrated from his birth state alone. There were other Cobles/ Caubles/Cobbles in TN in 1812.

It is safe to assume that the 26-year-old Peter Cauble owned no taxable property in 1812 since he declared none in 1813. But, was he in White Co. or was he with other Caubles\Cobles in a nearby county? A man served in the militia of the county of his residence. Peter had been of militia age for eight years.

Many Cobles lived in Lincoln Co. TN in the 1830s and 1840s. John M. Cobble [this could be John Martin Cauble who migrated to Tyler Co. TX and later married Mariah Jane Rotan] married Sophia R. Tensley 23 Jan 1844.

On Captain Thomas W. Hayes' Company, 1830 [Lincoln Co. TN] tax list are found Henry, Daniel, William, Peter, Christopher, John — Cobles all — and all on Bradshaw Creek. One Thomas Henly also held land on Bradshaw Creek. This could be Sophia's father. [Early Unpublished Court Records of Lincoln County, Tennessee, compiled by Helen C. and Timothy R. Marsh (Greenville SC: Southern Historical Press, Inc., 1993), 183.] "Bradshaw's Creek, a north branch of Elk river, in Giles County, S.E. of Pulaski and below Carr's creek, on the line of Lincoln County." [Tennessee Gazetteer 1834, 118]

1813 — **Peter Cobble** paid 1 poll and **Richard M. Rotton** paid 1 poll in White Co. TN. [1813 Tax List, White Co. TN.]

16 Feb 1813 — **Richard M. Rotton, J. A. Lane,** and **David Smyth** served as witnesses when **William Rogers**, Barren Co. KY paid \$465 to **Jonas Turner** for 100 acres on waters of Calf killers fork. Rogers received the land by Tennessee Grant No. 3499. The tract began on the west boundary of **Samuel Thomas** 220-acre survey. [White Co. TN Deed Records, Vol. E:143]

“**Calf-killer river**, a north east branch of the Caney Fork of Cumberland, which rises in the Cumberland mountains northeast of Sparta.” [Tennessee Gazetteer 1834, 123.]

10 Apr 1813 — The will of **William Roden** (signed 26 Oct 1811) was entered for probate in Barnwell District SC. The will mentions wife, **Mary,** and **7 children, naming William, John, and Simeon,** who received the deceased's 185-acre tract of land. [Barnwell Dist. SC Probate Records, Bundle 20, Package 5, Book 5, p. 327.]

c1814 — **Lucinda Cauble** who later married **Robert Hughes** was born to Mary Ann Rotan and Peter Cauble in White Co. TN. [1830 U. S. Census, Franklin Co. AL; 1850 U. S. Census; Peter Cauble Will, Tyler Co. TX Probate Records, Vol. D, pp. 885-887; David Barclay to John Mc Barclay, letter, 26 Sep 1852, location of original unknown to editor.]

Tennessee Militias

TN Militias — “Early Tennessee militia organizations were formed according to the laws of North Carolina. Each county was to have a separate regiment, subdivided into companies under elected captains. All able-bodied men aged eighteen to forty-five were required to serve—exceptions being such persons as elected officials, ministers of the gospel, and justices of the peace.” [Gale Williams Bamman, “Research in Tennessee,” *National Genealogical Society Quarterly* 81:2 (June 1991), 117.]

Militias in Early America [1770s-1816] held monthly militia musters, called training days. All able-bodied men between the ages of *sixteen and sixty* were members of the militia. — *jcs*

28 Jan - 10 May 1814 — **Peter Cauble** and **John A. Rattan** served as privates in **Captain Richard M. Ratton’s Company of Infantry, Colonel Robert Steele’s 4th Regiment, West TN Militia**, which was called into federal service against the Creek Nation. Private Cornelius Bryant/Bryan served in their company, but his record states that his service ended 23 May 1814. [Muster Rolls of 4th Regiment of TN Militia, TN State Library and Archives; *Natchez Trace Traveler* 8:4 (Nov 1988), 131; *Tennesseans in the War of 1812*, transcribed by Byron and Samuel Sistler (Nashville: Byron Sistler & Associates, Inc., 1992), 118, 419; *Record of Commissions of Officers in the Tennessee Militia, 1796-1815*, compiled by Mrs. John Trotwood Moore (Baltimore: Genealogical Co., Inc., 1977), 103-104.]

The Sistlers state that the men who were involved in actual fighting served in the Creek Indian War of 1813-1814 (which was a sub-conflict of the War of 1812) or they were part of the New Orleans campaign which ended in the American victory at Chalmette in January 1815. Given the date of their dismissal from service, it can be assumed that they **fought the Creek if they engaged in active campaigning**. — *jcs*

About the War of 1812 — “The army had neither an able staff nor an adequate force of enlisted men. The U. S. Military Academy at West Point, founded during Jefferson’s administration in 1802, had produced only eighty-nine officers by 1812. The army thus turned to political leaders and state militia to organize volunteer companies, and not all states cooperated. Much of the war effort, including planning, was decentralized. The government offered enlistees a \$16 sign-up bonus, \$5 monthly pay, a full set of clothes, and promise of three months’ pay and 160 acres of western land upon discharge. Recruiting officers received a \$2 premium for each enlistee. Among those who joined, 42 percent were illiterate.

Tennessee Militias

“On the frontier, recruitment went well at first. Civic spirit and strong anti-Indian sentiment stimulated thousands of enlistments from the Old Northwest, Kentucky, Tennessee, and the southern frontier. Within a year, however, frontier enlistments declined. Word spread that the War Department was often slow in meeting its payroll and supplying clothing.” [Mary Beth Norton, et al., *A People and A Nation*, Vol. 1, 4th ed. (NY: Norton, 1994), 252-253]

Mar 1814 — The TN Militia under General Andrew Jackson defeated the Creek nation at the Battle of Horseshoe Bend. This battle ended the year-long Creek War and began Jackson’s rise to political prominence. The Creeks had to cede two-thirds of their land and withdrew to southern and western Alabama. [Norton, et al., 256.]

20 Sep 1814 — **Richard M. Rattan** was enrolled in the 2nd Regiment of West Tennessee Militia under the command of Col. **Alexander Lowrey** of White Co. TN. [Muster Rolls of 2nd Regiment of TN Militia.]

01 Oct 1814 — **Richard M. Rotton** was dismissed from service. [Muster Rolls of 2nd Regiment of TN Militia.]

1815 — **Peter Cauble** paid 1 poll. **William Rotton** paid *no* white poll [over age] and 4 black polls; Rotton was taxed on 330 acres on Lost Creek, White Co. TN. [1815 Tax List, White Co. TN.]

21 Dec 1815 — **Richard M. Rotton of Warren County TN** deeded to Shadrack Mooneyham of White Co. TN for \$200 a tract of 57 acres on main Caney Fork and the signature was witnessed by **John A. Rotten** and **George Yeat**. The document was recorded 25 Oct 1817 and witness **John A. Rotten** was then “Beyond limits of this state.” [White Co. TN Deed Records, Vol. F, p. 103.]

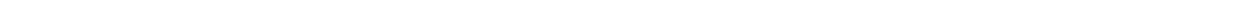

Polls, which were originally taxes for being or more specifically taxes on a man's potential as a worker, are listed because they offer proof of county residence. Men over age 55 were exempted from the poll. Amounts of other taxes are not listed because they have no genealogical value.— jcs

1994 Reunion

1995 Reunions

Vice President **Kiefer Cauble** will serve as chairman of the 1995 Texas Cauble Family Association meetings. He and his committee have planned two meetings—the *first* at Camp Ta-Ku-La near the historic Peter Cauble House on Farm Road 2097, leading northwardly from Chester, Texas, to nowhere in northwestern Tyler County and the *second* at Cottonwood Park on the east side of U.S. Highway 70, leading northwardly from Sweetwater, Texas, to Roby, Texas, in central Fisher County. The date for the one-day Saturday meeting in Fisher County is **15 July 1995** and details will be given in the March newsletter. The gathering at Ta-Ku-La in Tyler County is slated for the weekend of **23-25 June 1995**.

Camp Ta-Ku-La is a Christian retreat that provides meals in its cafeteria and features dormitory sleeping with separate arrangements for males and females. It presents a wholesome family environment since its buildings are smoke-free and its premises are alcohol-free. The accommodations costs per person range from \$30 for one night and two meals to \$42 for two nights and five meals. This location provides the unique opportunity for Cauble descendants to tread the same ground once walked and worked by our progenitors, **Mary Ann Rotan and Peter Cauble**. The historic house will be open for a family tour on Saturday afternoon and a brief wreath-laying ceremony and prayer are planned in the Cauble-Burch Cemetery following the house tour.

The reunion committee must comply with a camp reservation policy by submitting an advanced booking fee of \$3 for each reservation by 15 January 1995. Although the association can cover the booking fees until descendants register with the treasurer at the meeting, Kiefer needs an estimated count by 10 January 1995.
