

## Section H

**H. J. Throckmorton** (1849-unknown) was a son of **Anne [Annie] Rattan** (25 March 1829-31 October 1895), and **James Webb Throckmorton** (01 February 1825 Sparta, White County, Tennessee-21 April 1894; buried Pecan Grove Cemetery, Collin County, Texas), who married on 20 January 1848 in Greene County, Illinois and arrived in Collin County, Texas, in February 1848. The Throckmorton household was recorded in Collin County on the 1850 U. S. census. **H. [Wade Hampton] Rattan/Ratton** (1831 Illinois-unknown), a son of **Nancy Waggoner** (about 1810s-1843 Paris, Lamar County, Texas) and **Littleton Rattan** (about 1810-18 December 1847 killed by Indians during the Mexican War), was a laborer and lived in the household of his uncle, **Dan Waggoner**, in Fannin County, Texas, on 27 January 1851. **J. [Jarvis Franklin] Ratton/Rattan**, (about 1834 Illinois-unknown), 17, and **Davis Ratton/Rattan** (about 1836 Illinois-unknown), 15, Wade Hampton Rattan's brothers, also lived in the household. **Hampton Rattan** married **Amanda Nix** on 22 December 1855 in Fannin County, Texas. **H. Rattan** was age 30 when he enlisted as a private in Fannin Precinct 8 Company, 14<sup>th</sup> Regiment under Captain **William Nail** and General **S. A. Roberts** on 06 July 1861. **Hampton Rattan.** See **Wade Hampton Rattan** or **H. [Wade Hampton] Rattan**.

**Harriett Rattan** (about 1824 Carrollton, Greene County, Illinois-unknown) was a daughter of **Gillian Hill** (25 September 1792 Georgia-1870 Texas; buried Throckmorton Cemetery, Collin County, Texas) and **Thomas Rattan** (1787 South Carolina-11 November 1854 Texas; buried Throckmorton Cemetery, Collin County, Texas) and a granddaughter of **Mary Greene** (January 1755 Anson County, North Carolina-12 August 1827 Alton, Madison County, Illinois; buried Vaughn Cemetery on Wood River and Bethalto Road near Alton, Madison County, Illinois) and **John Rattan** (1747 North Carolina-11 October 1821 Madison County, Illinois; buried Vaughn Cemetery on Wood River and Bethalto Road near Alton, Madison County, Illinois). **Harriett Rattan** married **Andrew Jackson Witt** on 06 May 1841 in Greene County, Illinois. **Henry Rhoaden** received 170 acres of land in Logan County, Kentucky, on 14 November 1798. [*Kentucky Land Grants*, Book 9:299, Logan County, online Ancestry.com, accessed 30 October 2004]

**Henry Rotan** (unidentified) had surveyed a tract of 100 acres of land on Little Barren River in Green County, Kentucky, in 1798. Barren County was a part of Green and Logan counties of Kentucky in 1792, when Kentucky was formed. According to the Barren County Surveyor's Book, the first surveys after Barren County was formed were entered in 1799. **Henry Rotan** (January 1876 Texas-unknown) was the second child of **Ann Polk** (July 1846 Texas-unknown) and **Robert Rotan** (1822 Alabama-after February 1887 Polk County, Texas) and grandson of **John A. Rotan** (1794 South Carolina-by October 1858 Tyler County, Texas). His parents were married on 01 October 1871 in Tyler County, Texas. His siblings were **John E. Rotan** (05 November 1874 Texas-unknown), **Alice Rotan** (January 1880 Texas-1947; buried Mount Hope Cemetery, Tyler County, Texas), and **Nettie Rotan** (November 1887 Texas-unknown). On 27 June 1900 Henry's mother was a widow and farmed rented land with the help of Henry. His sisters, Alice and Nettie, lived with her. All could read, write, and speak English. **Henry Rotan** (01 May 1880 Texas-unknown) [unidentified] lived in Tyler County, Texas, was single, and worked as a day laborer on 29 June 1900. He was able to read, write, and speak English. [Henry Rotan household, 1900 U.S. census, Tyler County, Texas, population schedule, Precinct 3, ED 104, SD 8, sheet 15, page 174, line 75, dwelling 262, family 274, 29 June 1900, Family History Library roll 1241674]

**Henry Roten** was listed on the 1790 U. S. census in Orangeburg County, South Carolina, with 1 free white males 16 years and over, 1 free white males under 16 years, and 4 free white females. **Nehemiah Roton** 3-0-3 lived nearby. Conclusion: Henry and Nehemiah were surely connected. [Nehemiah Roton household, 1790 U. S. census, Orangeburg County, South Carolina, district unknown, NARA M637, roll 111]

**Hiram Rattan** (about 1805 Kentucky-after 22 October 1850), a son of **Mary Buford** (1782 Tennessee-after 16 November 1850) and **Richard Rattan** (1776 Tryon, Polk County, North Carolina-after 1831) and a grandson of **Mary Greene** (January 1755 Anson County, North Carolina-12 August 1827 Alton, Madison County, Illinois; buried Vaughn Cemetery on Wood River and Bethalto Road near Alton, Madison County, Illinois) and **John Rattan** (1747 North Carolina-11 October 1821 Madison County, Illinois; buried Vaughn Cemetery on Wood River and Bethalto Road near Alton, Madison County, Illinois) was a farmer in 1850. Hiram Rattan married **Leah Scholl** (about 1805 Kentucky-after 22 October 1850) on 15 June 1827 in Pike County, Illinois. By 27 November 1830, Hiram Rattan's household was recorded in Greene County, Illinois, by Richard Rattan, enumerator of the census. Both Hiram and Leah were age 20 to 30. Two daughters, under five years old, lived in their household. Hiram Rattan and his family migrated from Illinois to Texas by 1836. Five children and a son-in-law lived with the couple in 1850; they were **Permelia Rattan**, age 19 and born in Illinois, **Melinda Boren**, 17 and born in Illinois, Melinda's husband, **Richmond Boren**, 25 and born in Arkansas, and **Volney Rattan**, 16-year-old daughter born in Illinois, **Merill Rattan**, a fourteen-year-old son born in Texas, and **Cerilda Rattan**, a ten-year-old daughter born in Texas. **Melinda Rattan** married **Richmond Boren** on 18 April 1850 in Hopkins County, Texas. **Permelia A. Rattan** married **Joel P. Blackwell** on 25 January 1855 in Hopkins County, Texas. [Hiram Rattan household, 1830 U. **Hulda Rotan** (about 1840 Missouri-unknown) was age 40 and lived in Cass County, Texas, with her two sons, **William Rotan** (about 1860 Missouri-unknown), age 20, and **Johnie Rotan** (about 1866 Missouri-unknown), age 14, on 06 July 1880. Any possible relationship between the family of Hulda Rotan and other Texas Rotan families is unknown. [Hulda Rotan household, 1880 U.
