



Lucinda Cauble

Lucinda Cauble (c1813 Tennessee-after 1840 Marion County, Alabama federal census; buried probably in Marion County, Alabama), daughter of Mary Ann Rotan and Peter Cauble, married **Robert Hughes** (1792 Tennessee-between 04 and 28 September 1852 Tyler County, Texas), a hatter, about 1830 probably in Marion County, Alabama. The couple had two known sons. Robert Hughes came to Texas in 1839 and received a conditional land certificate. He settled in the part of Liberty County that became Tyler County. By the summer of 1849, he apparently contracted an illness that rendered him unable to care for himself or Butler. They became dependent upon the county for their livelihood.



B1 **Jesse C. Hughes** (before 20 December 1831 Alabama-1862 Civil War), son of Lucinda Cauble and Robert Hughes, was age eighteen when his father became unable to care for himself and Butler. By 1850 Jesse C. Hughs was a farmer in Tyler County, Texas. But by 1854, after the death of his father, he paid taxes in Hill County, Texas, as taxpayer 75, on 200 head of cattle, valued at \$1,200. He continued to pay taxes in Hill County through 1860. On the 1860 Federal Census, he lived in the household of Jas. E. Cook, age 37 and born in South Carolina, and his wife, Mahala, age 20 and born in Alabama. Any kinship between the Hughes brothers and the Cooks has not been found. Jesse served as a private in Hill County Volunteers, 4th Regt. TC, Company A, 12th Texas Cavalry or Dragoons, Confederate States of America, until his death. He never married.



B2 **Isaac Butler Hughes** (29 October 1838 Alabama-10 August 1875 Hill County, Texas; buried Old Woodbury Cemetery, Hill County, Texas), son of Lucinda Cauble and Robert Hughes, paid a poll in Hill County, Texas, in 1860. On the 1860 Federal Census, he lived in the household of Jas. E. Cook, age 37 and born South Carolina, and his wife, Mahala, age 20 and born Alabama. Butler also served in Company A, 12th Texas Cavalry or Dragoons, Confederate States of America. His headstone stated that he was age 32 at his death. Isaac Butler Hughes married **Mary M. Witty** (May 1848 Alabama-02 July 1876 Hill County, Texas; buried Old Woodbury Cemetery, Hill County, Texas), daughter of Susan E. ____ (12 June 1817 Alabama-18 December 1895 Hill County, Texas; buried Old Woodbury Cemetery, Hill County, Texas) and Carroll Witty (06 November 1818 Alabama-19 September 1898 Hill County, Texas; buried Old Woodbury Cemetery, Hill County, Texas), about 1867 in Hill County, Texas. The headstone of Mary M. Hughes identified her as a daughter of C. and S. Witty and as age 28 at her death.



B21 **James M. Hughes** (1868 Hill County, Texas-unknown), a son of Mary M. Witty and Isaac Butler Hughes, was listed as a two-year-old son and born in Texas on the 1870 census.

B22 **Alice B. Hughes** (1869 Hill County, Texas-unknown), a daughter of Mary M. Witty and Isaac Butler Hughes, was listed on the Hill County, Texas, assessment rolls for years 1880 and 1881 with property inherited from her father.
