



# James W. Cauble

James W. Cauble (1832 Marion County, Alabama-31 August 1867 Hardin County, Texas; buried unknown) lived with his parents in Tyler County, Texas, on 16 November 1850. He married **Sarah Ann Butler** (08 June 1840 Alabama-12 September 1885) on 11 December 1857 in Polk County, Texas. The couple lived in Tyler County when the 1860 census was taken. He served in Company A, 3rd Battalion, 13th Regiment, Confederate States of America in 1862. The couple had three known children during their brief marriage. James W. Cauble met a sudden death in 1867 in Hardin County, leaving his wife with a daughter and a son to raise alone.

Sally Cauble, age 30 and born Alabama, was listed as the head of her household in Tyler County, Texas, on 22 June 1870. She lived with her daughter, Jemminy [Jemina] Cauble, age 7 and born Texas, and her son, Thomas Cauble, age 4 and born Texas. Sally and her children lived next door to Almira and Valentine Burch, the sister and brother-in-law of her deceased husband. Living in Sally Cauble's household in the summer of 1870 was Frank Muster, age 26 and a mulatto, his wife, Patsy Muster, age 23 and mulatto, and their three children, John Muster, age 6, Frank Muster, age 4, and Wiley Muster, age 1.

The widowed Sarah Ann Butler Cauble secondly married **John F. Bellamy** (29 December 1830 Mississippi-22 July 1898) on 01 September 1874 in Tyler County, Texas.

**I1 Mary Jane Cauble** (28 July 1860 Tyler County, Texas-28 August 1864 or 1866 Polk County, Texas) was born to Sarah Ann Butler and James W. Cauble twenty-six days after the census was taken in 1860. Sarah Ann Butler Cauble's Bible gives the only record of her life. **The State** } Indicted for an assault with Intent to Kill  
vs } And now comes the state of Texas by her attorney  
**James Cauble** } Sam A Wilson and the Deft James Cauble  
being solemnly called and came not and John

W Cauble Peter Cauble and T H Huse being solemnly called to come into Court as they were bound to do and bring with them the body of James Cauble to answer the state of Texas upon a charge contained in a bill of Indictment for an assault with intent to Kill one James Sterling came not but wholly failed to produce the body of the said James Cauble to answer the State of Texas upon said charge and it appearing to the Court that in the 14th day of April 1856 said James Cauble and his securities John W. Cauble Peter Cauble and T H Huse executed and delivered to one Wm S Ingham shff of Hill County their Bond in writing for the sum of \$1000 Condition that the said James Cauble make his appearance at the Court House in the Town of Woodville Tyler County on the 4th Monday after the 3rd Monday in March 1856 then and there to answer said charge and shall not depart the Court without leave thereof which said Bond was approved by W. I. Ingham Sheriff of Hill and filed on the 20th day of October 1856 and the said parties being solemnly called before forfeiture and they failing to comply with the conditions of the Bond It is therefore considered by the Court that the state of Texas have and recover of the said James Cauble and his security John W. Cauble Peter Cauble and T H Huse the sum of one Thousand Dollars and all cost in this behalf expended and that sci facias Issue to the sheriff of Hill County commanding him to summon James Cauble J W Cauble Peter Cauble and T H Huse to appear before the Hon. the District Court of Tyler County at its next regular term thereof to show cause if any they can why the aforesaid judgment against them of one Thousand Dollars should not be made final and execution issued therefor. It is further ordered that an alias capias Issue to Hill County be continued.
