
### Families of Peter Cauble and Valentine Burch Were Early Settlers in Tyler County, Texas

#### Peter Cauble, Early Texas Settler

**Peter Cauble** (1786 - 9 March 1870) was born in North Carolina, where he apparently received a good education and reportedly taught school at some time. Before 1810 he migrated to White County, Tennessee, and met his future wife, **Mary Ann Rotan**, a daughter of **William Rotan**, a native of South Carolina. The couple probably married in White County and soon had two daughters and a son in that county—believed to have been **Elizabeth**, **Lucinda**, and **John W. Cauble**.

By the time **Helen Elmira** was born on 15 August 1819, the family had moved to Alabama. **Isaac Butler** was born 25 December 1820 in that state. Daughters **Sarah** and **Martha** were probably also born in Alabama. The two youngest sons listed their birthplaces as Alabama—**Peter**, **Jr.**, born in 1829 and **James W**. born in 1832. Sometime after James W. was born and about 1839, Peter Cauble permanently settled his family in Texas.

For several years Cauble, like other Tyler County settlers, used land to which he owned no legal title. Part of that land had been awarded to a military officer under the Gavino Aranjo Grant, issued by the Mexican government on 17 March 1834. However, the Aranjo Grant remained unclaimed by its owner. The Cauble family built their landmark house at Peach Tree Village by the late 1830s, being among the first non-Native American residents in the area. Peter Cauble listed his holdings as 5,000 acres of land and sixteen slaves on the 1860 U. S. census. Peter Cauble and Mary Ann Rotan Cauble are buried in Cauble-Burch Cemetery, a few hundred yards from their historic home.



Valentine Ignatius [Bob] Burch, above, was born 14 February 1813 in Bullit County, Kentucky, a son of Dorothea Brown and Samuel Lewis Burch. He married Helen Elmira [Ann] Cauble, a daughter of Mary Ann Rotan and Peter Cauble, in 1841. The Burches and some of their descendants lived in the Historic Peter Cauble House at Peach Tree Village. Bob and Ann Burch are buried in the Cauble-Burch Cemetery near the house.

aforesaid being feeble in health but of sound mind and memory make this my last will and testament to wit: 1st It is my will and desire after death to be buried in a manner suitable to my circumstances and condition in life.

2nd It is my desire that after the payment of the expenses of my last illness all my just debts may be paid as soon as shall be convenient and proper.

3rd I will and bequeath unto my wife Mary L. Cauble the following property to wit my horse Selina 50 Bushels of corn 4 cows and calves choice of the four 1 Feather Bed and one bedstead and 1 Blanket 1 counterpain and two Sheets and [illegible and smeared].

4th I also bequeath unto my daughter Almira Burch, in consideration of her kindness to me during my last illness one feather bed and all the remaining bed clothes after taking out those [illegible] to my wife.

5th I desire that my remaining effects shall be equally divided share and share alike [among] my living children Butler D Cauble, Almira Burch, and Marty Green my daughter Almira Burch to share equally with the others as though the former bequest herein made had not been made and heirs of my deceased children John W Cauble, Peter Cauble, James W Cauble, Elizabeth Osborn, Lucinda Hughs, and Sarah Weights.

6th I hereby appoint W W Whitehead my executor to carry into effect this will.

7th I hereby appoint B.A. Cook, Henry S. Kirby and Henry West commissioners to provision and distribute my Estate.

8th It is my will and desire that the business of my estate shall be fully settled and closed as soon as shall be convenient and proper
after my death and I further desire that
no other action shall be had in the county
court or any other court pertaining to
Estates than probate of this will and the
filing of an inventory of my remaining worldly possessions.

[Note: Signing official documents with one's mark did not necessarily mean that one could not write. It was custom and each mark was distinctive. Peter Cauble's mark was a Y or a wishbone which dipped slightly toward the right margin.]

#### Notes:

The Cauble-Burch Cemetery and the restored house are located two miles north of Chester, Texas, in northwestern Tyler County on Farm Road 2097. The cemetery is less than .5 mile northeast of the Christian retreat at Peach Tree Village and Kirby Chapel. The five acres of land surrounding the cemetery and house are now owned by Tyler County Heritage Society and leased and maintained by the Christian retreat.

Peter Cauble and his wife, Mary Ann Rotan, settled on the land surrounding this cemetery in the late 1830s. The house occupied by the Caubles was listed as a landmark when the boundaries of Polk County were set in 1846. Helen Elmira Cauble was one of five daughters and five sons born to the Caubles. She married Valentine Ignatius Burch, veteran of the Battle of San Jacinto. The Burches and their descendants lived in the house after the deaths of Mary Ann Rotan and Peter Cauble.

Because of the size of the cemetery and the piles of stones in various locations, several unmarked graves are believed to be located in the Cauble-Burch Cemetery. The Cauble Family Association hopes to document any other known burials. 

My father, *Guy H. Morris, Sr.*, who is now seventy years of age, [and I]...are descendants of *James Burch*, brother to *Valentine Burch* who married *Helen Elmira Cauble*. Our *James Burch*, son of *Samuel Lewis Burch* and *Dorothea Brown*, married *Martha Simms* 9-28-1841 and had 12 children, one of which was *James Valentine Burch* who married *Callie Eugenia Mantooth. James* and *Callie* had 3 children, one of which was *Sarah Burch* who married *Guy H. Morris II*, and from that union, my father, *Guy H. Morris III* was born.


