March 1836 Brought the Hope of Spring and the Fight for Freedom

As early spring of 1836 brought promise of new growth in grass and flowers about the countryside, it also sparked the flame of Texas Independence. In the dark cold days of February 1836 and for months before, early Texas settlers suffered under the repressive regime of Mexican dictator Antonio Lopez de Santa Anna, who had destroyed the Constitution of 1824, denying Texans all individual rights. Even though early March saw the fall of the Alamo and the deaths of all Texans who fought there, it was followed later by the massacre of more at Goliad. But Santa Anna and his large army were destined to be defeated at San Jacinto in the coming month. By the time the wild bluebonnets and paintbrushes covered the fields in late April, Texans were free of Mexican rule-if not of Mexican attacks. Settlers returned to their farms and cabins to begin again in the beautiful land of promise with planting time at hand. We owe our freedom as Texans to these brave early settlers.

Texas Flag

FOLDING

THE FLAG In 2009 state senators Judith Zaffirini and Leticia Van de Putte sponsored legislation on how to fold the flag. Here are the proper steps:



1. Fold in half lengthwise, with the red stripe facing up.



2. Fold in half lengthwise again, with the red stripe concealed on the inside of the fold.



3. With the star facing the ground, fold a corner of the white stripe over to form the edge of a triangle, then continue folding to the opposite end.



4. Tuck in the edge to secure. The flag will be shaped like a triangle, with part of the star showing.





1. When displaying the flag horizontally, the white stripe must be on top, with the blue stripe to the observer's left. (Fly the flag upside down only to signal distress.)

3. When flying the U.S. flag and the Texas flag from adjacent poles, the U.S. flag should be to the observer's left (though it is recommended that both flags be at the same height).



2. when hanging the hag vertically, the blue stripe should be uppermost, and the white stripe should be to the observer's left.

Note: Fly your flag on state holidays. If your neighbor flies his flag unlighted after dark or in the rain, there is no Flag Police to whom you may report him. Some people just never learn to show respect!

The Defendant being solemnly charged pleads not guilty, afterwards came Jury to wit: William Boyce, Nathan Ward, Benjamin Coyle, James Coyle, John Sratt, John Taylor, Jr., Alexander Cook, Samuel Terry, **Garrett Fitzgerald**, Thomas Taylor, Daniel Morris and **William Roaden [Rottan]** being empanelled and sworn after retiring find the defendant guilty of an "assault" only, and is fined in the sum of Twenty-five Dollars, and the costs. And ordered in custody of the sheriff till paid. Fifteen dollars of the above fine remitted by the Court. The above defendant John Perkins is released from the custody of the Sheriff and ordered by the Court that facias issued against him for the fine and costs.

Comment: Volume 7 begins on 13 October 1806 with pages 2-4. Pages 5-16 are missing from Volume 7. **William Rottan** and **Garrett Fitzgerald** lived in White County on 14 April 1807 and were acting as responsible citizens by serving on a jury.

Three, Two, One Cake

Who doesn't love warm cake? Well, I have just the fast and easy way to fix yourself a little treat in less than one minute. It is called the ... Three, Two, One Cake

1. Mix together in a gallon-size Ziploc baggie:

1 box angel food cake mix

1 box any flavor cake mix. [I use the Supreme mixes.]

2. Close the zip top and move the bag around for several minutes to completely combine the two cake mixes.

3. Using a set of measuring spoons, add 3 Tablespoons of the cake mix in the bag to a coffee mug that is microwave safe.

4. Add 2 Tablespoons of water and mix well with a small wisk.

6. Remove from oven and top with Cool Whip Lite. And enjoy.

Bluhm. He married Flora Faye Cauble, a daughter of Ada Jane Morgan and Peter Jefferson Cauble H12. Earl was a farmer, an avid fisherman, and a member of the First United Methodist Church in Austwell. On 11 September 1943 she married J. C. Wendell Cauble (17 November 1914 Fisher County, Texas-15 October 1996 Hamlin, Jones County, Texas; buried Hamlin Memorial Cemetery, Jones County, Texas), a son of Eva McClung and Frank E. Cauble H24. Although Mary worked for various businesses in Hamlin, she devoted many hours of service to the First United Methodist Church, where she was secre-

tary from 1971 until her retirement in 2008. Her thirty-seven years as church secretary covered the tenures of fifteen pastors. On 21 April 1836, General Sam Houston and his rag-tag Volunteer Army of Texas with 750 men were camped only a short distance from the large and well-provisioned force of 1500 Mexicans under Antonio Lopez de Santa Anna at San Jacinto. After Houston sent spy Deaf Smith to burn the only bridge that allowed escape, he determined it was time to attack the Mexicans about 3:30 when they were at afternoon *siesta*. The element of surprise gave the small Texas army the advantage they needed to rout the Mexicans and eventually capture Santa Anna, who signed the treaty to end the war.

Among those early Texans with General Houston at San Jacinto were Valentine Ignatius Burch (1813-1892) and his

brother James. Valentine Burch later married Helen Elmira Cauble (1819-1889), a daughter of Mary Ann Rotan and Peter Cauble, Sr.
