Cauble-Rotan Family Research

Michael A. Ports C611111 continues his search for the early Rotan family and Cauble family:

The muster roll of the 4th Regiment of Tennessee Militia, commanded by Colonel Robert Steele, is on microfilm at the Tennessee State Library and Archives. The original manuscript is also there, but I have not seen it. The 4th Regiment was called into federal service on 28 January 1814 and served until 10 May 1814. One of the companies was commanded by Captain Richard M. Ratton. On the muster roll appear the names of John A. Rattan and Peter Cauble, both privates. Curiously, there were no other names of interest on the muster roll. I have no idea what military service these men may have seen during their brief tour of duty. More research is needed to determine where the regiment was stationed.

On 20 September 1814 Richard M. Rattan was enrolled in the 2nd Regiment of West Tennessee Militia, under the command of Colonel Alexander Lowrey, as quartermaster with the rank of lieutenant. Colonel Lowrey was from White County, Tennessee. Richard M. Rottan was dismissed from service on 1 October 1814, making a short tour of duty.

Recall from my last writing that our William Rotan had left Barren County, Kentucky, and moved to Jackson County, Tennessee, during the summer or autumn of 1800. In Jackson County on the 1802 tax list of Captain Lowery's District William Rotten paid the tax for one poll and three slaves. He held no real property.

On the same list in Captain Jabez Fitgerald's District, Garrot Fitzgerald paid the tax for 1,111 acres, but no poll. The 1803 tax list of Captain Parson's District shows our William Rotton with one poll and three slaves and Richard Rotton with one poll [meaning he was at least 16 in 1803]. Captain Fitzgerald's District included Garret Fitzgerald with 1,000 acres, no poll, and 4 slaves and Jabez Fitzgerald with one poll.

No other tax list is extant until year 1837, which is too late for our research. White County was formed from Jackson County in 1806. I am still working on the Rotans who migrated into Alabama and Mississippi.

Notes From Our Research

- Mary J. Cobble married David Hudler in 1872 in Angelina County, Texas: No David Hudler was indexed on 1880 U. S. census.
- Lucinda Cauble Hughes and Elizabeth Cauble Osborne: Nothing! One James Osborne married an Elizabeth Latham in 1871 in McLennan County, Texas. His first wife was also named Elizabeth, but we cannot prove connection.
- Sarah Cauble Wates [Weights/Watts]: Not found on censuses.
- Martha Cauble Green Keesee: Three of her sons were listed on page 392, Brown County, Texas, 1880 census as the following entries show: 111/111 T. G. Green, 27, Texas, Alabama, Alabama [Thomas G.], M. A., 16, Tennessee, Tennessee, Tennessee [wife]; 112/112 W. H. Green, 23, Texas, Alabama, Alabama [William H.]; M. P., 25, Texas, Tennessee, Alabama [wife]; W. B., 2, Texas, Texas, Texas [son]; M. A. 6/12, Texas, Texas, Texas [dau]; John Keesee, 14, Texas, Texas, Texas [half-brother].
- John Keesee (19 July 1866-13 July 1943) and his wife, Martha H. (30 July 1866-20 March 1910) and several children are buried at Macedonia Cemetery on Weedon Ranch near the entrance of Lake Brownwood State Park, Brown County, Texas.
- Cobble/Cauble listings in Lincoln County, Tennessee marriage records: John M. Cobble married Sophia R. Tensley on 23 January 1844; William Cobble married Elizabeth Brown on 16 March 1843; William Cobble married Mary Brazier on 27 October 1847.
- Lincoln County, Tennessee, 1840 census, page 16, showed John M. Cobble, 1 male 20-30, 1 female 20-30, 2 females under age 5. Page 65: George Cobble, 1 male 20-30; 1 female 20-20; 1

male under age 5. Page 16 recorded Anne Cobble, 1 male 15-20; 1 male 10-15, 1 male 5-10; 1 female 40-50; 1 female 15-20, 1 female 10-15.

Lincoln County, Tennessee 1850 census noted Abraham Cobble, 24; Deborah, 22; George Cobble, 45, with family—Mary, 30, Willis, 11, Nancy, 10, Martha, 8, Mary Ann, 6, Henry, 2. Wm. W. Cobble, 30, with family—Mary 32, James, 6, Spicy A., 1.

John M. Cobble was not listed in 1850 on Lincoln County, Tennessee census. We have no record of John M. in Texas prior to 1846. Our John's age and those of his daughters fit the John in Lincoln County. Our John was remarried in 1847—after reaching Texas—to Mariah Jane Rotan. This John married Sophia Tensley in 1844. What happened to her if this is the same John M. Cobble? Who were the other Cobbles in Lincoln County?

McLennan County, Texas 1870 census, page 10, recorded the family of Edward Rotan, 26, teacher, born Tennessee; Kate, 19, born Kentucky, Martha Rotan, 62 born Tennessee [daughter of our William Rotan].

We have not found Elizabeth Fitzgerald and Sarah Garnett after 1845.

Lucinda Cauble probably married Robert Hughes in Alabama about 1830 and the couple may have come to Texas with her parents.
