Note about the poll tax in Tennessee during this time period: A poll tax was a tax on white men between the ages of 21 and 50 years. The tax was one levied on one's self, on one's potential during his prime years. A tax was also levied upon slaves—male and female—and this tax became an actual property tax for the slaveholder, since the slave did not have the means to pay his or her own poll. On later tax lists, the ages that a tax was levied upon slaves was given as 12 to 50 years.
